

All the books complete in all respect will have to be delivered by the printer within 07 days from the date of handing over the complete and final manuscript falling which penalty at the rate of Rs.5000/-(Rs. Five thousand only) per book per day subject to maximum 20% of the work order will be deducted from the bill.
3. The quality of the work, design and get up of printing of the documents, cover and colour consistency shall have to be maintained which will also be monitored by team of this office. The samples of the books are available in this office and it can be seen on any working day.
4. Absolute confidentiality of the matter is to be maintained.
5. The manuscript of printing may be collected from this office and be returned to this office immediately after completion and delivery of the printed books.
6. The quotations must be accompanied with the EMD of RS. 5000.00 (Rs. Five thousand only) which shall be in form of a crossed Demand draft/Banker,s cheque from and Nationalized Bank in favour of the Pay and Accounts Officer, Office of the Accountant General (A&E)-I, U.P. Allahabad payable at Allahabad. Quotations not accompanied with earnest money will not be considered.
7. Earnest money will be refunded to the unsuccessful vendors after acceptance of quotation is conveyed to the successful vendor only.
8. Successful bidder should deposit 5% of performance security money of the total value of work order in shape of bank guarantee /FDR/TDR from a commercial band. The performance guarantee will be prepared in favour of the Pay and Accounts Officer, Office of the Accountant General (A&E)-I, U.P. Allahabad after award of contract.
